QUESTION: Which facilities are receiving the ICE allocations (including previous ICE allocations)?

RESPONSE: Listed below are the ICE ordering locations:

- El Paso Service Processing Center
- Montgomery Processing Center
- Tacoma ICE Processing Center

QUESTION: How many orders are ICE and BOP placing? Could you break these down by facility?

RESPONSE: Attached is an overview of ICE and BOP orders.*

QUESTION: How many orders are being placed by states and aren't being fulfilled because of supply?

RESPONSE: Currently, no BoP orders are not being fulfilled. Each week, our therapeutics team reaches out to BoP notifying them of their allocation amount/amount they can order. We then ask them what amount of that number they need/would like to order. For those allocation dates where BoP's allocation is noted as zero, it means that BoP told us they did not need any of their allocated amount. We have had reached out multiple times to BoP asking them why they do not want their allocations offered by HHS. They consistently say they have enough to meet demand/their demand is low.
