A BILL

To restore military priorities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Restoring Military Pri-
5 orities Act of 2020”.

6 **SEC. 2. RESTORATION OF REPROGRAMMED FUNDS.**

7 All amounts transferred under the Department of
8 Defense reprogramming action FY 20-01 RA, “Support

1 for DHS Counter-Drug Activity Reprogramming Action”,
2 shall be restored to the appropriation accounts and the
3 programs, projects, and activities for which such amounts
4 were appropriated or otherwise made available by the De-
5 partment of Defense Appropriations Act, 2020 (division
6 A of Public Law 116–93).

7 **SEC. 3. LIMITATION ON GENERAL TRANSFER AUTHORITY.**

8 Section 8005 of the Department of Defense Appro-
9 priations Act, 2020 (division A of Public Law 116–93;)
10 is amended by striking “\$4,000,000,000” and inserting
11 “\$1,798,000,000”.

12 **SEC. 4. LIMITATION ON OVERSEAS CONTINGENCY OPER-**
13 **ATIONS/GLOBAL WAR ON TERRORISM TRANS-**
14 **FER AUTHORITY.**

15 Section 9002 of the Department of Defense Appro-
16 priations Act, 2020 (division A of Public Law 116–93;)
17 is amended by striking “\$2,000,000,000” and inserting
18 “\$371,000,000”.
